Notice of Award

WHEREAS, the National Headquarters, Philippine National Police (NHQ PNP) has provided the amount of **Four Hundred Forty Thousand Seven Hundred Twenty Five Pesos and 00/100 (Php 440,725.00)** funds from the **Approved Program of Expenditures-Program of Activity PNP Trust Receipts for 2nd Quarter CY 2014 (POE-PA PNPTR)** dated **January 08, 2015** for the **Procurement of Generator Sets** for the use of **Police Regional Office 3 (PRO 3)**;

WHEREAS, on August 23 to 30, 2016 the Regional Bids and Awards Committee posted on PhilGEPS requesting for quotation for the Procurement of Ten (10) 5KVA Generator Sets;

WHEREAS, there were two suppliers in the PHILGEPS who signified in the Document Request List: First, the Solid Steel Machinery and Tools Inc. with office address at # 67 Sen. Gil Puyat Avenue, Makati City but no quotation was submitted and second, Cred General Trading submitted their price quotation;

WHEREAS, Cred General Trading with office address at Fiesta Homes, Barangay Malpitic, City of San Fernando, Pampanga submitted their price quotation amounting to Forty Four Thousand Pesos Php 44, 000.00 per unit for a total of **Four Hundred Forty Thousand Pesos and 00/100 (Php 440,000.00)**;

WHEREAS, on August 30, 2016 Tanedo Variety of Dau Supermart Mabalacat City, Pampanga offered a price of Fifty Five Thousand Pesos Php 55,000.00 per unit for a total of **Five Hundred Fifty Thousand Pesos 00/100 (Php 550,000.00)**;

WHEREAS, on the same date Sherlyn Variety Store at Dau Supermart, Mabalacat City, Pampanga offered a price of Forty Five Thousand Pesos Php 45,000.00 per unit for a total of **Four Hundred Forty Five Thousand Pesos (Php 445,000.00)**;

WHEREAS, upon evaluation on the request for quotation of different proponents, two of the proponents particularly Tanedo Variety and Sherlyn Variety Store submitted quotations exceeded the approved budget of the contract, while the offered price from Cred General Trading is within the ceiling of the approved Budget of the contract and has the lowest quotation. Further verification disclosed that Cred General Trading met and presented all the minimum required technical requirements/documents as well as complying in the required NAPOLCOM specifications;

NOW, THEREFORE, PRO3 RBAC with the approval of RD, PRO3, Awards the Contract to Cred General Trading for the **Procurement of Ten (10) units of 5 KVA Portable Power Generator Sets** compliant with the Approved Standard Specifications indicated in **NAPOLCOM RESOLUTION 97-015**, with the contract amount of Four Hundred Forty Thousand Pesos and 00/100 (Php 440,000.00) as provided for in **Section 53.9 of Revised Implementing Rules and Regulation of RA 9184**, in compliance with all the requirements provided for by law, rules and regulations and subjected to the Test and Evaluation by the Inspection and Acceptance Committee.
