INVITATION TO APPLY FOR ELIGIBILITY AND TO BID
SUPPLY AND DELIVERY OF 5.56 M193, AMMUNITION AND
CARTRDGE 9MM, BALL AMMUNITION

1. The Police Regional Office 3 (PRO3) through Regional Bids and Awards Committee (PRO3 RBAC) from NEP FY 2021 intended for the months of January to June 2021 (1st Semester 2021) intends to apply the sum of **Three Million Three Hundred Pesos (Php3,300,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract from January to March 2021 for the procurement of **Cartridge 5.56mm, M193 Ammunition/PRO3-GDS-01-03-002-010321** and **Three Million Three Hundred Pesos (Php3,300,000.00)** being the ABC to payments under the contract from April to June 2021 for the procurement of **Cartridge 9mm, Ball Ammunition/PRO3-01-04-04-002-04062**.

2. The PRO3 now invites bids for the above Procurement Project. Delivery of the Goods is required by the Procuring Entity after Post Qualification Report and Issuance of Notice to Proceed. Bidders must have an experience of having completed a similar project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders). Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

5. Prospective bidders may obtain further information from Police Regional Office 3, Bids and Awards Committee (PRO3, BAC) and inspect the bidding documents at the address given below from 8:00 A.M. to 5:00 P.M. (Mondays to Fridays only).

6. A complete set of Bidding Documents may be purchased by the interested bidders on November 18 to December 9, 2020, 8:00 A.M. to 5:00 P.M and on December 9, 2020 before 8:00 A.M. from the address below and upon payment of a non-refundable fee at the Regional Finance Service Office 3 for the bidding documents specified above.

7. The Police Regional Office 3 will hold a Pre-bid Conference on **November 26, 2020 at 9:00 AM**. Bids opening shall be on **December 9, 2020 at 9:00 AM** at **PRO3 Conference Room, Camp Captain Julian Olivas, City of San Fernando, Pampanga** and/or through videoconferencing/webcasting via zoom , which shall be open to prospective bidders and observers.

8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on December 9, 2020 on or before 9:00 o'clock in the morning at the PRO3 Conference Room, Camp Captain Julian Olivas, City of San Fernando, Pampanga. Late bids shall not be accepted.

9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.

10. Bid opening shall be on December 9, 2020 @ 9:00 o'clock in the morning at the PRO3 Conference Room Camp Captain Julian Olivas, City of San Fernando, Pampanga. Bids will be opened in the presence of the observers, and bidders' representatives who choose to attend the activity.

11. The **Police Regional Office 3 Bids and Awards Committee** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award, in accordance with Section 35 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of R.A. 9184, without hereby incurring any liability to the affected bidder or bidders.
