WHEREAS, on the same date **Imperial Appliance Plaza** at Mc Arthur H-way, Brgy., Dolores, City of San Fernando, Pampanga submitted their price quotation for a total of **Three Hundred Seven Thousand Nine Hundred Seventy Pesos (Php 307,970.00)**;

WHEREAS, the **CGS Solid Aircon & Refrigeration, Inc.** at Lazatin Blvd., Villa Victoria Road, Brgy., Dolores, City of San Fernando, Pampanga submitted their price quotation for a total of **Three Hundred Five Thousand and Sixty Five Pesos (Php 305,065.00)**;

WHEREAS, upon evaluation on quotation provided by different proponents, **CGS Solid Aircon & Refrigeration, Inc.** has the lowest quotation. Further verification disclosed that **CGS Solid Aircon & Refrigeration, Inc.** met and presented all the required technical requirements/documents;

NOW, THEREFORE, THIS BOARD HAS RESOLVED, AS IT HEREBY RESOLVES, to recommend the Award of Contract to **CGS Solid Aircon & Refrigeration, Inc.** for the Procurement and Installation of **a.) One (1) Unit of 3 Tonner 4HP Air Conditioning Unit b.) Two (2) Units of Split Type 2.5HP Air Conditioning Unit and c.) One (1) Unit of Window Type 1HP Air Conditioning Unit**, with the contract amount of **Three Hundred Five Thousand and Sixty Five Pesos (Php 305,065.00)** as provided for in **Section 53.9 of Revised Implementing Rules and Regulation of RA 9184**, compliance with all the requirements provided for by law, rules and regulations and subjected to the Test and Evaluation by the Inspection and Acceptance Committee.
