1. References:

- a. Attached Email received from POSTMASTER@pnp.gov.ph on May 7, 2018 at 10:10 AM;
- b. Computer Security Bulletin CSB18-03 Phishing Revised on March 14, 2018 at www.itms.pnp.gov.ph; and
- c. Section 4a (para 3 and 4) of Republic Act No 10175, also known as the "Cybercrime Prevention Act of 2012."

2. This pertains to a recent phishing attack via email sent by POSTMASTER@pnp.gov.ph <carlos.neto@embrapa.br> with the subject line "[Phishing-Suspeita] ACCOUNT UPGRADE." Said email advises recipients to click a link to update their account and will be directed to a fake website which will ask for personal information.

3. In this regard, all PNP personnel, are advised to initially validate all incoming e-mails received to avoid possible security breaches. Also, once a message is received with the same description, immediately close the message, report it as a spam and inform ITMS thru the following:

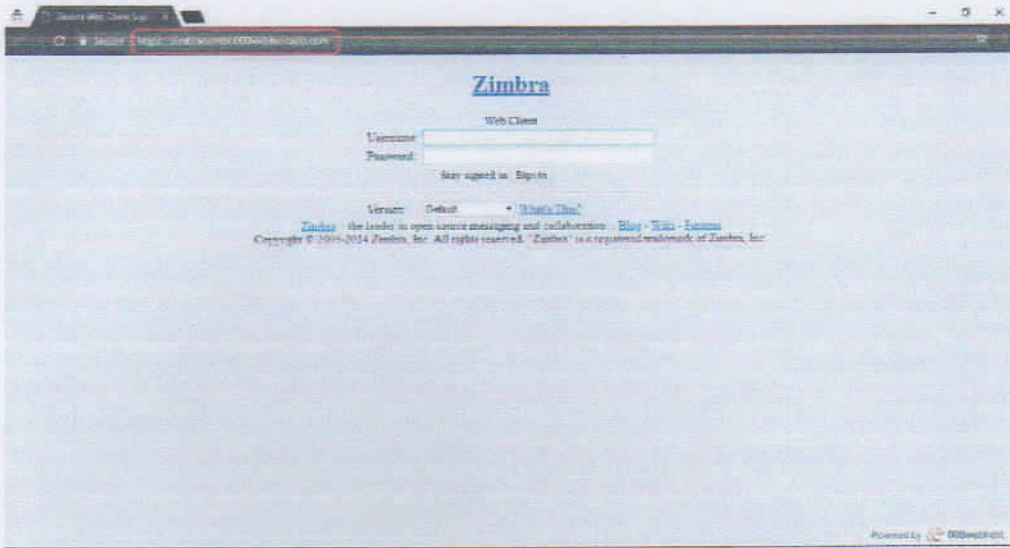
